

## ASVAB Required Reporting 2021-2022 School Year

### Introduction

[Senate Bill \(SB\) 1843](#) (85th Texas Legislature, Regular Session, 2017) requires that the Texas Education Agency (TEA) not later than August 1 of each year, publish a list of school districts and open-enrollment charter schools that elected not to provide the Armed Services Vocational Aptitude Battery test during the previous school year.

### Notes

1. The data included in this report were reported to the TEA through the 2021-2022 PEIMS fall data submission.
2. Districts and open-enrollment charter schools report the data in data element C217 (ARMED-SERVICES-VOC-APT-BATTERY-INDICATOR-CODE).<sup>1</sup>
3. Districts and open-enrollment charter schools serving students in grades 10-12 that are not included in this report did not certify the C217 data element in the 2021-2022 fall data submission. These districts' ASVAB or alternative test status are unknown by TEA.
4. There is no alternative data or errata reporting method.
5. Districts and open-enrollment charter schools who did not certify C217 in the 2020-2021 fall data submission but did offer the ASVAB or an alternative test to students in grades 10-12 should consider maintaining local records of offering the ASVAB or alternative test available to students.<sup>2</sup> Staff should work annually to schedule time to meet this reporting requirement in future school years.
